

# SADDLE ADDENDUM

## PLEASE INCLUDE IF SENDING A SADDLE

This document constitutes an Addendum to the Consignment Agreement between below signed name ("Consignor"), and Greta's LLC ("Greta's") Consignee, on the below signed date subject to the terms of the Consignment Agreement in addition to the following Terms and Conditions:

**COMMISSION TAKEN BY GRETA'S LLC:** Greta's, LLC accepts saddles to our consignment store. Greta's, LLC agrees to sell Consignor's saddle(s) and share in any profits from the sales of such items. Greta's, LLC shall determine the asking price for saddles. After Greta's collects a 25% commission on the sale of the saddle, Consignor shall receive 75% of the sale price minus actual shipping and insurance costs of the saddle thirty(30) days after completed sale.

**PAYMENT:** Consignor has the option to receive compensation from the sale of his/her saddle in the following forms, and **must choose one below**, otherwise a paper check will be delivered via standard mail to the address provided by the Consignor on this contract:

- A. Consignee will send a paper check via regular mail for the sale within 30(thirty)days following the date of completed, not returned, sold item(s), and be sent to the address provided by Consignor on this form; this option comes with no fees.
- B. Consignee will submit a transfer of funds by direct deposit to the Consignor's checking account via routing number provided by Consignor to Consignee within 30(thirty) days following sell date of completed, not returned sold item(s); this option comes with no fees, and Consignee's banking information will never be saved, stored, or used henceforth.
- C. Consignor will submit a transfer of funds to the Consignee's either PayPal or Venmo account, this option has a minimum 3.49% + fixed fee of .49 cents per transaction charge.
- D. Charitable donation. Consignor must choose location and charity within the continental United States within one(1) week(7days) of completed sale, not returned sold item(s). If no charitable entity is declared then Consignee will choose on Consignors behalf.

# SADDLE ADDENDUM

**SHIPPING:** Please note saddles will be shipped via Greta's LLC standard shipping practices as noted on the website, consignment contract, and saddle purchase agreement to customers, if saddle does not work for customer they will be subject to Greta's Return Policy terms and the price of the saddle will be refunded less re-stocking fee, processing, shipping and insurance expense so long as the saddle is returned in the condition it was shipped. Please refer to our Return Policy or contact Greta's, LLC with any additional questions or concerns.

**RISK OF LOSS:** Consignor expressly agrees that the use of Greta's saddle consignment service is at your sole risk, Greta's is not responsible for any loss or damage of any kind to Consignor's person or property incurred as a result of the use of the saddle consignment service. Greta's is not responsible for damage or loss to saddles during shipping.

**REPRESENTATIONS AND WARRANTIES:** All products and services delivered to you through the saddle consignment option are (except as expressly stated by us) provided 'as is' and 'as available' for your use, without any representation, warranties or conditions of any kind, either express or implied, including all implied warranties or conditions of merchantability, merchantable quality, fitness for a particular purpose, durability, title, and non-infringement. It is up to Consignor to properly fit and check the saddle for any impairments which may cause injury to horse or rider.
